CGSUSA

In the 48 years of Catechesis of the Good Shepherd being available through formation courses in the United States and with the presence of the United States Association of Catechesis of the Good Shepherd for the past 39 years, we have seen the mustard seed of catechesis for children become rooted, watered, and growing well in our country. With over 4000 active members from 21 Christian traditions, we offer support and resources to parents, catechists, and others serving children. We estimate that Catechesis of the Good Shepherd serves 135,000 children and their families in over 6750 atria found in churches, schools, and homes throughout the United States. We have developed a library of 91 books and publications. We believe there may be approximately 6,500 catechists trained in CGS in our country. These catechists volunteer over 36,000 hours of monthly community service in their work with children, parents, and other caregivers, as well as with pastors and principals in parishes and schools.

We offer catechist support and resources to several countries, including England, France, Ireland, Scotland, Norway, Slovakia, and South Africa, to name a few. In addition, we serve in various ways the Missionaries of Charity in our country and around the world.

Catechesis of the Good Shepherd (CGS) has been in existence now for almost seventy years, listening deeply to children and their spiritual questions, discovering what resonates in their relationship with God. The Catechesis of the Good Shepherd has grown and spread amazingly. At last count it is in 54 countries: Australia, Austria, Argentina, Bolivia, Brazil, Canada, Czcech Republic, Chile, Colombia, Croatia, Ecuador, England, France, Germany, Guatemala, Haiti, Honduras, , India, Indonesia, Ireland, Italy, Japan, Kenya, Latvia, Lithuania, Malaysia, Nicaragua, Mexico, New Zealand, Norway, Paupa New Guinea, Philippines, Romania, Singapore, Thailand, Pakistan, Panama, Peru, Portugal, Poland, Puerto Rico, Rwanda, Serbia, Bosnia, Slovenia, Spain, South Africa, South Sudan, Switzerland, Tanzania, Trinidad, Uganda, Uzbekistan, Uruguay, the United States, Venezuela.





OUR PURPOSE

CGSUSA's purpose, prepared in consultation with Sofia Cavalletti and Gianna Gobbi, is to assist the involvement of children and adults in a common religious experience in which the religious values of childhood, primarily those values of contemplation and enjoyment of God, are predominant.

OUR MISSION

CGSUSA's mission is to support catechists, parents, and others in the Church and beyond, as they grow in their understanding of the religious potential of children.

OUR VISION

WE will work to make the Catechesis of the Good Shepherd and the writings of Sofia Cavalletti and Gianna Gobbi accessible to all.

Recognizing the need for clear and available communications, we will avail itself of written, voice and visual electronic media to maintain contact with catechists and others.

We will provide formation in accordance with the work of Sofia Cavalletti and Gianna Gobbi, through the provision of a discernment process and training for formation leaders, offering regular retreats and conferences and the use of approved formation leaders' handbooks. In addition to current sites, courses in the Catechesis of the Good Shepherd will be held in colleges, universities, and seminaries across the United States.

We will support the work of the International Council and work in harmony with it.

Material changes and new materials as recommended by the International Council will be translated and distributed to formation leaders and catechists through the National Association. We will provide a manual at each level with accurate and most excellent plans and schematics for constructing atrium materials.

Regional groups will be encouraged in every part of the nation.

We will establish and maintain links with diocese and denominations represented by the membership and other formation and educational groups. The National Association will provide help and resources to assist catechists in adapting this work to the liturgy of their denominations.

We will establish and maintain historical archives of the Catechesis of the Good Shepherd, making them accessible to members.

A MESSAGE FROM THE PRESIDENT



This year I couldn't stop thinking about how the mustard seed grows from such smallness into a tree that shelters the birds of the air. A habitat not just for one kind of bird but a place a variety of birds call home.

While we are not yet who we will become we continue to make good progress. We have expanded into offering more resources for organizations like churches and schools while maintaining our resources for individual catechists. Podcasts reach out not only to members, but to others who seek to know the religious life of Christian children.

Combining your donations and membership dues with the Lilly grant has made it possible for us to focus more on catechesis before

age three. We have been struck by the love these little ones show for the Holy Bible and for the communal meal, breaking bread together. More catechists will serve these youngest ones and their parents through the development of formation courses and adults to lead these courses.

Donations to the Tina Lillig Memorial Fund have made it possible to do much more this year. We awarded scholarships to catechists, grants for materials to churches and schools, and increased the number of bilingual courses for adults to better serve our Spanish speaking communities. These funds also reduced the cost of formation at National Courses in South Dakota, where the surrounding area had been underserved.

There is much to celebrate in this annual report. We sent association ambassadors to meetings of the USCCB, FORMA, The LA Congress, and the National Black Catholic Congress. We know that our association members were also planting seeds for our work in their churches, schools, and dioceses. Empowering members to reach out to our neighbor. As individual members, vendor members, and organization members we are all sheltering one another. Members helping members, and friends helping friends, a sign of the kingdom of God among us.

The Association also received its second audit since 2014. We received a 2nd clean (unqualified) opinion, and the auditors identified no material weaknesses or significant deficiencies.



THE TINA LILLIG MEMORIAL FUND



The mission of the Tina Lillig Memorial Fund is to support the growth and development of Catechesis of the Good Shepherd through catechist formation, missionary outreach, and the work of the United States Association of The Catechesis of the Good Shepherd (CGSUSA).

To these ends, the Tina Lillig Memorial Fund offers a source of **financial aid (in the form of partial scholarships)** to applicants who would find paying the full tuition of a course to be a hardship. The Tina Lillig Memorial Fund is a source of **grants** for missionary outreach to organizations working to open atria in underserved regions of the United States.

The Tina Lillig Memorial Fund also **supports the purpose, mission and vision of the National Association** through direct support to the Association. Monies for financial aid and grant awards come from direct donations to the Tina Lillig Memorial Fund from members of the United States Association

of The Catechesis of the Good Shepherd (CGSUSA) and others who are interested in supporting this aspect of the work.

Over \$198,600 has been distributed since the inception of this fund in 2002. Ninety catechists have been supported in their formation with the average award of \$250. More than one hundred communities have been supported with grants for courses and materials.

This past year the TLM Fund supported the CGSUSA Vision by providing translation services, publication, and an orientation workshop for the *new I am the Good Shepherd* book series, provided support for Spanish speaking or Bilingual courses where we have Spanish speaking catechists in the formation Do you or your community need financial support? Apply to the TLM Fund!

RESPONSE TO THE GIFT

As the Association has grown, so has the number of projects in support of our members. For any nonprofit organization, raising money is a challenge. For us, this is especially true because our way of life is rooted in a spirit of poverty and essentiality. Therefore, how do we best ensure a stable future for the work of CGSUSA? How do we best invite a prayerful response of time, talent, and treasure? How can we become more sustainable as a community? While we have a number of possiblities, the three primary ways are through the Annual Appeal, the Tina Lillig Memorial Fund, and by Major Gift donations by those with the capacity and heart for the child.

Annual Appeal Each year we send out a call for support of our mission. Gifts to the Annual Appeal provide vital operating support and help to sustain and grow our Formation, Publications and Membership plans.

The Tina Lillig Memorial Fund (TLM) was created to support the growth and development of Catechesis of the Good Shepherd through catechist formation, missionary outreach, and the work of CGSUSA.

Major Gifts

Cash: CGSUSA is grateful for any gift, large or small, that supports the work of nurturing the child's relationship with God. Donations in the form of recurring gifts or multi-year pledges help us to plan responsibly. Donors have the option to create monthly, quarterly, or annual giving schedules.


Appreciated Stock makes an excellent charitable gift. Under current tax laws, when an appreciated asset (such as stock) is sold, a capital gains tax is due. By making a charitable gift of the appreciated stock, you can avoid or delay the capital gains tax. You can also take an immediate income tax deduction for the current fair market value of the stock, no matter what was originally paid for it.

Legacy Gifts: A bequest through your will or trust is one of the most simple and popular ways to make a gift that will live on after you. You can make a gift bequest to benefit CGSUSA by providing a dollar amount, specific property, or a percentage of your estate, either designated or undesignated. A Legacy Gift can reduce your estate taxes. In many cases, a simple change to your will can add this bequest and does not require rewriting your most recent will.

Life Insurance is another simple way to make a substantial future gift at a level that might not be possible for a straight cash donation. Name CGSUSA as the owner and beneficiary to receive the proceeds of an existing life insurance policy. You will receive a tax deduction for the approximate cash surrender value, thereby reducing your tax liability in the year of the gift.

CGS FORMATION HIGHLIGHTS



CGSUSA is privileged to sustain and advance the legacy of the Catechesis of the Good Shepherd in the United States through catechist formation. The Association serves as THE resource to the CGS community in forming catechists and formation leaders in this method. We also offer guidance to catechists, church and school leadership in creating and maintaining atrium environments that nurture the religious life of children.

Over 220 CGSUSA Catechist Formation Courses have been completed this past fiscal year, and 2282 certificates were awarded. We have 238 courses registered with our association at this time. We service these courses through a course registration process, responding to various

questions and providing resources to hosting site coordinators and formation leaders, and sending CGSUSA Certificates upon course completion. More than half of the 200 CGSUSA-recognized formation leaders (about 130) actively serve these courses. There are approximately 80 catechists involved in the Formation Leader Discernment Process for recognition as Level I, Level II, or Level III Formation Leaders.

The Office of Formation, in collaboration with other CGSUSA staff:

Sponsored two national catechist formation courses in Rapid City, South Dakota – Level II and Level III that began June 14-23, 2022, and concluded June 13-22, 2023. Participants attended from the Northern Plains – North and South Dakota - as well as from other states and three countries (The Netherlands, Canada, and South Africa). Level II was co-led by Marty O'Bryan and Diane Olsen. Level III was co-led by Julie Baltuska and Marilee Quinn.

Sponsored and facilitated the second Gather and Grow, A Gathering for Episcopal and Anglican Catechists, October 24-28, 2022, in Atlanta, GA.

Sponsored and facilitated the first annual Infant-Toddler Catechist Conference, December 1-3, 2022, in Scottsdale, AZ, for catechists who completed Infant-Toddler Formation. We are also working diligently on documentation of catechist formation and the observations from catechists serving toddlers as part of the Lilly Grant we received for the Infant-Toddler initiative. This included 2022 site visits to Toddler Atria in Iowa, Virginia, and Arizona.

Sponsored another national Infant-Toddler Catechist Formation, with Part 1 March 20-26, 2023, in Atlanta, GA, with 47 participants and led by Elizabeth Calanchini. Part 2 will be at the same location on March 17-22, 2024.



Sponsored and facilitated a hybrid Formation Leader Discernment Seminar beginning February 2023. Part 1 had five online meetings, and Part 2 is onsite in Atlanta, GA, October 2-6, 2023, for 50 catechists actively involved in the Formation Leader Discernment Process.

Planning an Orientation to the I Am the Good Shepherd Year 1 Books for Spanish-speaking catechists facilitated by Claudia Margarita Schmitt and Beatriz Hernandez for August 2023.

Our work continues to reach around the globe as we offer services and resources to catechists and formation leaders in other countries, particularly Canada, South Africa, Indonesia, Taiwan, Norway, England, France, Poland, Slovakia, and Slovenia.





THE GROWTH OF MEMBERSHIP



Three areas of growth this year have centered upon the accomplishment of our digital resources, the increase in our membership in both numbers and response to member needs, and the continued development of our regional groups, especially in relationship with our upcoming anniversary celebration in 2024.

Digital Resources

We provide our members with an array of regular digital resources each month, as well as support pieces through the year that offer nourishment and help sustain them in their ministry and offer convenience in not only the ease of use but for the accumulation of the most excellent sources.

The monthly parent newsletters are a prevalent communication piece for families, which are also shared by parishes and (arch)diocese on their respective websites, etc.

The open rate for our monthly digital resources is consistently at 65-77%, which exceeds industry standards which sit at 37-44%.

Membership Growth

We have seen strong growth of our work at the local, in the (arch)diocesan, and regional communities. Our membership has grown by 15.93% over the previous year. Our membership includes individual catechists as well as organizations, i.e., churches, schools, diocese, seminaries, universities, regional groups, etc. In the last year, our membership grew to 4,203 members, and two months into the first quarter of the new year we have surpassed 4,450 members. We project that we will exceed 4,750 active members in the coming year.

A significant part of our growth has been an outreach to our organization members via the establishment of regular zoom gatherings. This year we will offer our first zoom gathering for those that offer The Catechesis of the Good Shepherd in the school setting. the Good Shepherd in a traditional or parish school setting is a gift for the entire school community. The spirituality that is nourished in the Atrium environment has the potential to permeate the entire school community, and to assist the family in living their faith more authentically at home. We have also continued to offer additional resources that serve to impact their role in the community. Since the formation of our regular zoom gatherings, we have also seen a growth and interest in regional groups, which allow for our members to connect with and build relationships with one another.

Regional Groups

The relationship and the collaboration among members are held in the vision of CGSUSA "Regional groups will be encouraged in every part of the nation." The regional group is a place where our members find local support and fellowship. In our first Organization Zoom Gathering, we focused on connecting with other members, and to have the opportunity to discuss what is the most urgent or pressing need for their community.

As we look towards the future and our fortieth anniversary as an association, we will invite our regional groups to help identify team members facilitate the sharing of information, i.,e., the mapping (census) of atria, the history of CGS in each of the regions, and the documentation of this current moment in our history.



RESOURCES IN SPANISH

We are seeing an increase in the need for resources for Spanish speakers and are working to meet that need in a variety of ways. During the past year we have moved Life in the Vine along the translation process, and it is now in its final stages at Liturgy Training Publications. The Commemorative Journal for our 40th Anniversary will be available in Spanish as well as in English.

This past year three Spanish language courses were subsidized to better provide for the increased demand for formation in Spanish. The course locations were chosen in places where a Spanish speaking catechist was identified as a possible future formation leader to allow for mentoring with

hopes of increasing the number of Spanish speaking formations leaders. Subsidized courses were held in Georgia, in Texas, and in California.

With the Lilly grant, we have begun development of a 13-segment 30-minute video series. This series will allow CGSUSA to share with parents, caregivers, pastors, and others ministering to the family in the church, showcasing best practices for nurturing the young child's relationship with God. It will be in both languages.

We held an orientation to Year 1 of I am the Good Shepherd in Spanish.

We continue to use Lexicon, as we are tonight, to make events more accessible to our Spanish speaking catechists.

The Spanish speaking staff and committee are committed to meeting the needs of Spanish speakers in our association and providing translation assistance to make resources available.


The Roots of Change

CGSUSA.ORG, the website and digital home for the United States Association, has a refreshed design as of July 2023. What is less visible are changes in other systems and tools used by CGSUSA to perform daily tasks ranging from processing store orders to accepting donations and membership renewals to formation course registration. Changes with the previous website's host set CGSUSA on the current path to make these strides into the future, and it is likely the path CGSUSA would have chosen for this particular year. But, like the mustard seed, we must grow in the soil where we are planted and rely on


the strong roots of our past. The changes we make this year, however challenging, will create a foundation for continued growth and will permit CGSUSA to explore additional offerings and newer tools.

The Year in Review

While much work has gone into the transition of the tools and systems over the past year, it was also necessary to continue to maintain CGSUSA. ORG and serve our members to the best of our abilities. During 2022-2023, 88.5% of site visitors were based



in the United States. Canada, the United Kingdom, Singapore, Australia, and France comprise the top five international locations, and 100 countries hosted five or more annual visitors to CGSUSA.ORG. Visitors from all 50 states and the District of Columbia accessed CGSUSA.ORG this year, and Texas, Virginia, Illinois, Ohio, and New York and were home to the greatest number of visitors. We've been monitoring the increasing number of site visitors accessing the site using mobile devices over the past several years. This year, visitors are now evenly split between those who use a traditional desktop or



laptop computer and those who use a mobile phone or tablet to view the site. This will be important to our new site design and to our member and visitor support plans going forward. We remain committed to providing excellent member and visitor support throughout the implementation of all projects this year, and we will be refining responsibilities throughout the first half of next year.





The Good Shepherd and the Child podcast, hosted by Kerri Mecke-Lozano, continues in its third season with 25 new episodes. The podcast has been downloaded almost 80,000 times this year, a 56% increase over last year! This year featured several multi-episode series dedicated to topics of special interest, including book studies and family life.

The Next Stage

Throughout 2022-2023, we have been planting the seeds and tending the roots of a new tree for CGSUSA. With the recent launch of the redesigned CGSUSA.ORG, we see the first stalks of this new plant begin to emerge. The 2023-2024 year will be full of

growth and change for the CGSUSA staff, and we hope to begin to expand offerings on the website and beyond soon. The lesson of the slow-growing mustard seed starting small and creating room to accommodate many is an excellent guiding principle to hold close during this time.

LILLY ENDOWMENT INC. GRANT In support of our Infant-Toddler Catechist Formation and Development of Atria



For many years we have been attentively studying how to better serve children who are younger than three years of age in a way that is in keeping with the spirit of the Catechesis of the Good Shepherd. In doing so we are also mentoring their parents, caretakers, catechists, faith communities and pastors. We are actively engaged in observing young children's responses to the encounter with Christ in the same manner that our co-founders did in their early years with three- to twelve-year-old children. In this new work, we are looking to see the youngest child, as well as ourselves, in light of our dignity through Baptism as "children of light" and as "priest, prophet and king", pondering selected Scripture and liturgical texts that nurture our relationship with God. We are considering how the most essential themes of CGS could be offered to the youngest children, accompanied by appropriate CGS materials, in addition to materials modeled on those

of the AMI Assistants to Infancy Training Course. We are also exploring the environments, the "atria", for the youngest from their beginning and how these environments can best be prepared to meet the religious potential of the youngest child. The children's response has been beautiful, consistent, and amazing.

The Lilly Endowment became aware of our work and invited us to apply for three grants to support our work with the youngest children. We received grants for a total of \$1,230,000.00 to strengthen our

Infant Toddler ministry in atria across the United States. With this grant we will continue to gather research from around the country, document the experiences catechists are observing in working with the youngest children, develop Infant-Toddler formation courses, workshops, media and technology and resources for those who care for and form the youngest of these children. This grant contains a five-year plan that will be an ongoing, sustainable part of our association's mission and vision. It contains:



• Catechist Formation and Course Content

We have had 18 seminal courses throughout the country, with 414 catechists receiving formation. We have referred to these courses as seminal until we had experienced the framework of the proposed content enough to know that this offers a good foundation for



preparing catechists to work with the youngest children and to see how this preparation gave insights and understanding to the infants and toddlers.

We are gathering observations from catechists and parents from their experiences in the formation and setting up toddler atria so that we can document our observations with the littlest ones. We are in the middle of a national course right now. We have 35 toddler atriums around the country and have been visiting several areas of the country where toddler atria have been established to meet with catechists and parents and learn more about these youngest children. To aid our efforts in documenting what is happening with infants and toddlers we are holding an annual Infant-Toddler Catechist Conference for those catechists who have completed the CGSUSA Infant-Toddler Formation courses.

• Formation Leader Recognition Process

We have developed a list of current Level I Formation Leaders and catechists who potentially could serve as Infant-Toddler Formation Leaders. We have held numerous discussions about what this formation leader will need to do in order to be best prepared for this role. We will invite potential candidates for this role to an Infant-Toddler Formation Leader Discernment Seminar which will be sponsored by the Lilly Endowment Grant.

• Atrium Environments for Nido and Toddlers

We are now making site visits to areas of the country where Toddler atria have been established. This is still a small, budding work. We are finding that these little ones have a great love for the Bible, every toddler atrium we have surveyed lifts this love and affection up as essential to these young children. We are also seeing the importance of the communal meal in light of the Eucharistic Banquet. The children show a great capacity for freedom and relationship with God, each other and the adults present. We are documenting what materials the children are most attracted to and how they use them. The prayer table, the meal table and the outdoor environment are most used by them. This grant also holds funds for the development of atria in the seven regions of our country. One environment has been built at the National Office in Scottsdale, Arizona. Another is being built in Marietta, Georgia with plans for building others around the country.






• Parent, Pastor, Priest, and Church Leadership Education



Baptism is a Beginning: With the grant from the Lilly Endowment, we will also have the opportunity to hold seven diocesan/regional workshops around the country that will help faith communities prepare parents, families, godparents, and sponsors for the Baptism of a child and provide continuing support and formation after the child's Baptism. *Baptism Is a Beginning (Bautismo Es un Comienzo) Bilingual Resource* is a book that contains 18 digital pamphlets can be accessed online and reproduced for distribution to families in either English or Spanish. This book is enriched by the insights of Sofia Cavalletti and Gianna Gobbi and edited by Rebekah Rojcewicz. Each event will host 175 people from churches, dioceses, CGS centers, and other church leadership. Each participant

would receive the Baptism is a Beginning book, along with related resources.



Preaching with Children: The grant will also provide for 7 Formation Workshops in Seminaries as part of clergy formation. These workshops, built from the book *Preaching with Children*, would offer practical help for ordained and lay ministers, preachers, and catechists in crafting specific homilies for children. The author of the book, Dr. Ann Garrido, would draw on insights gleaned from Catechesis of the Good Shepherd by helping preachers to understand key characteristics of childhood and children's spirituality. The workshop will also present ways to reflect on Scripture through the lens of the young child. Each event would host 75 seminarians. Each seminarian will receive

the Preaching with Children book, along with related resources.

We are also preparing a 13-segment 30-minute video series. This series will allow CGSUSA to share with parents, caregivers, pastors, and others ministering to the family in the church, best practices for nurturing the young child's relationship with God. We will produce two series, one in English and one in Spanish. We will also design and develop a mobile app for adults to access selected CGSUSA resources and tools, especially parent and caregiver resources

We are grateful for the kindness, help, and support of the Lilly Endowment staff and financial resources that have been shared with us. We believe that this viable and worthy project will be great benefit to countless children and adults. With St. Paul, we "kneel before the Father, from whom every family in heaven and on earth is named, that he may grant you in accordance with the riches of his glory to be strengthened with power through his Spirit in the inner self, and that Christ may dwell in your hearts through faith; that you, rooted and grounded in love, may have strength to comprehend with all the holy ones what is the breadth and length and height and depth, and to know the love of Christ that surpasses knowledge, so that you may be filled with all the fullness of God."



OUR WORK WITH THE UNITED STATES CONFERENCE OF CATHOLIC BISHOPS (USCCB)

We continue to work with the United States Conference of Catholic Bishops (USCCB) who have become even more appreciative of our unique approach in the Catechesis of the Good Shepherd. Each year CGSUSA is invited to attend the meeting of the USCCB Subcommittee of Evangelization and Catechesis which looks for consistency with the Catechism. This has been an opportunity to speak of the Association's work with children and adults. In a recent presentation from the Chair of the Evangelization and Catechesis, Bishop Andrew Cozzens, spoke about Evangelizing Catechesis. He made a statement regarding CGS: "I do believe the Catechesis of the Good Shepherd really has already been ahead of us in the whole model especially in terms of understanding the kerygma, accompaniment, and the whole understanding of the beauty of discovery. They have such a beautiful way to share the faith."

The Committee on Evangelization and Catechesis has developed a definition of evangelizing catechesis based on the new Directory for Catechesis to guide the work of both the Committee, the Subcommittee on the Catechism and this new Institute: "At the heart of the Church's mission to all people, an evangelizing catechesis seeks to deepen a personal encounter with Jesus Christ through the power of the Holy Spirit: It proclaims the core message of the Gospel, the kerygma; it accompanies people to a response of faith and conversion to Christ; it provides a systematic exposition of God's revelation within the communion of the Catholic Church; and it sends out missionary disciples as witnesses to the good news of salvation." Certainly, something that fits with our work.

To assist in living out this "Evangelizing Catechesis," a new **Institute on the Catechism** was launched by the USCCB in Baltimore, November 10-12, 2022. Mary Henrich and Mary Mirrione were invited to attend. This Institute is not a physical structure. Rather it is an "initiative" to accompany publishers and users of catechetical materials in changing times for the Catholic faith in the U.S., as more people leave the church, and the church sees a rise in Latino Catholics.

The Committee on Evangelization and Catechesis has also launched the National Eucharistic Revival which is a movement to restore understanding and devotion to the Eucharist in the United States by helping to renew our worship of Jesus Christ in the Eucharist. This event will take place July 17th – 21st, 2024 Indianapolis, Indiana, at Lucas Oil Stadium and other nearby venues in downtown Indianapolis. Mary Mirrione has been invited to serve on the committee for the family track and is working on this the committee to develop the NEC Family Care Working Committee Charter. Part of that charter is to look at programing. CGSUSA have been invited to offer talks on the religious life of children and to set up atria for the event for those children who are already in atria around the country and to help others know of the work. We will be offering breakout sessions for the families along with offering tHeART of the Child Art Exhibit, and a Nido environment, a Toddler atrium and Level 1, 2 and 3 Atria.

OUR BOARD OF TRUSTEES COMMITTEES

Development Committee

The Development Committee advises, supports, and collaborates with the Board of Trustees and the staff of CGSUSA. The responsibilities of the Development Committee include:

- working with board and staff to recommend realistic fundraising goals and creating appropriate action plans to achieve goals
- reviewing donations history on an ongoing basis and making recommendations for appropriate actions
- providing recommendations and monitor plans and goals for routine communication with donors, cultivating Major Gifts (\$1000 or more), increasing member donations, expanding constituency base (within the limits of available human and technology resources)
- helping generate creative content and realistic methods for the above.

Episcopal Committee

The Episcopal Committee supports, advises, and collaborates with the National Director and the Director of Formation on CGSUSA issues as they relate to the Episcopal community. The responsibilities of the Episcopal Committee may include:

- adapting formation content to meet the needs of Episcopal communities while staying true to CGS methodology and guiding principles
- adapting materials to meet the needs of Episcopal communities while staying true to CGS methodology and guiding principles
- evangelizing within and across Episcopal communities
- encouraging, supporting, and engaging Episcopalians in the work of the Catechesis of the Good Shepherd

Executive Committee

The Executive Committee serves the entire Board by providing preliminary review and clarity of items to be considered for future Board meetings. The responsibilities of the Executive Committee include:

- providing orientation and education to the Board in areas that include (but are not limited to) governance, human resources, development, and legal issues
- initiating a Strategic Plan
- establishing and overseeing working groups, as needed
- monitoring Board action items

Extraordinary Form Committee

The Extraordinary Form Committee supports, advises, and collaborates with the National Director and the Director of Formation on CGSUSA issues as they relate to the Extraordinary Form community. The responsibilities of the Extraordinary Form Committee may include:

- adapting formation content to meet the needs of the Extraordinary Form communities while staying true to CGS methodology and guiding principles
- adapting materials to meet the needs of Extraordinary Form communities while staying true to CGS methodology and guiding principles

Finance Committee

The Finance Committee advises, supports, and collaborates with the Board of Trustees and staff of CGSUSA in developing and maintaining effective financial practices. The responsibilities of the Finance Committee include:

• developing and maintaining sound financial and bookkeeping procedures

- monitoring the financial status of the association
- reviewing and making recommendations in consultation with hired, professional accountants on decisions that have a financial impact to CGSUSA

Formation Committee

The Formation Committee supports, advises, and collaborates with the Director of Formation in discerning the direction and content of the CGS Catechist Formation. The responsibilities of the Formation Committee include:

- supporting the development of, and collaborating in catechist formation and formation leader courses and resources
- clarifying current materials including updates, on an ongoing basis
- identifying and advising areas of ongoing catechist and formation leader formation
- supporting, advising, and collaborating on international work that surrounds formation, the CGS method, materials, catechist observations, and publications (including translations)

Governance and Nominating Committee

The Governance and Nominating Committee is a Board Committee that develops, oversees, and performs ongoing evaluation of the Association's policies. The committee monitors compliance of the Board, staff, members, and committees with CGSUSA bylaws. This committee also prepares a slate of candidates selected from nominations submitted by the membership for open positions on the Board of Trustees. The election is held at the Annual Meeting of CGSUSA members. The responsibilities of the Governance and Nominating Committee include:

- developing, overseeing, and performing ongoing evaluation of CGSUSA policies and bylaws every three years and recommending any needed changes
- recommending procedures for evaluating the Board and the Chairperson
- recommending ways to orient and educate Board members
- reviewing the job descriptions of responsibilities and expectations for Board members and the Board Chairperson
- recommending nominees for election and reelection to the Board, by utilizing a competency matrix that profiles the Board's current makeup compared to its list of needed competencies as a means of analyzing areas to emphasize in recruiting new Board members
- developing and implementing succession planning for the Board, including nominations, reelections, and elections of board members
- overseeing and reviewing the board's self-assessment and improvement process every one or two years
- engaging in ongoing consultation with legal counsel regarding legal and regulatory issues that affect governance

Journal Committee

The Journal Committee collaborates with the National Director and Liturgy Training Publications (LTP) to prepare, edit, and produce the annual CGSUSA Journal. The specific responsibilities of the Journal Committee include:

- consider theme for Journal beyond current year
- identify authors and solicit articles
- send releases to authors
- assign editors for articles
- complete edits and style to submit to LTP editor
- write letter from the Editors, back page
- determine art, prayers, and pearls for Journal
- receive and proof galleys

. Membership Committee



The Membership Committee supports, advises, and collaborates with the Board of Trustees and staff of CGSUSA to invite and welcome people from a broad spectrum of Christian denominations and geographic regions to become members of CGSUSA. The specific responsibilities of the Membership Committee include:

- inspiring members to remain and respond through their service in both the atrium and in the national association
- planning and cultivating membership drives (such as highlighting member benefits, utilizing social media for announcements, etc.)
- providing resources that support current members (up-to-date Membership Welcome Kits, regular communication with members, new member newsletters, etc.)
- providing resources to serve the children and their families in the atrium community (monthly parent newsletters)
- supporting the Membership Coordinator in implementing a Membership Marketing Plan that includes contacting and re-inviting "lapsed" CGS members
- providing updated information to the Membership Coordinator for the CGSUSA website, including the Atrium Locator
- cultivating ongoing fellowship and connection to the national and international community of CGS catechists
- strengthening and supporting regional work
- acquiring new members and retain and support existing members by responding to their needs as individuals, parishes, and regions
- encouraging active engagement of current members

Methodist Committee

The Methodist Committee supports, advises, and collaborates with the National Director and the Director of Formation on CGSUSA issues as they relate to the Methodist community. The responsibilities of the Methodist Committee may include:

- adapting formation content to meet the needs of Methodist communities while staying true to CGS methodology and guiding principles
- adapting materials to meet the needs of Methodists communities while staying true to CGS methodology and guiding principles
- evangelizing within and across Methodist communities
- encouraging, supporting, and engaging Methodists in the work of the Catechesis of the Good Shepherd
- developing Methodist sponsorship for special events and financial support for the work of the Catechesis of the Good Shepherd

Orthodox Committee

The Orthodox Committee supports, advises, and collaborates with the National Director and the Director of Formation on CGSUSA issues as they relate to Orthodox communities. The responsibilities of the Orthodox Committee include:

- adapting formation content and materials to meet the needs of Orthodox communities, staying true to CGS methodology and principles
- evangelizing within and across Orthodox communities
- encouraging, supporting, and engaging Orthodox Christians in the work of the Catechesis of the Good Shepherd
- developing Orthodox sponsorship for special events and financial support for the work of the Catechesis of the Good Shepherd

Spanish Speaking Committee

The Spanish Speaking Committee supports, advises, and collaborates with the National Director, the Spanish Speaking Coordinator, and the Director of Formation on CGSUSA issues as they relate to Spanish-speaking communities. The responsibilities of the Spanish Speaking Committee include:

• assisting with material manual translation



- assisting in prioritizing CGSUSA documents that need to be translated into Spanish
- assisting in identifying translators
- communicating the needs of Spanish-speaking communities in developing more bi-lingual atria
- evangelizing within and across Spanish-speaking communities.

Tina Lillig Memorial

The Tina Lillig Memorial Fund (TLM) Committee accepts and reviews applications for scholarships and grants, and recommends the disbursement of financial aid for scholarships, grants and missionary outreach that support the mission and vision of CGSUSA. The Tina Lillig Memorial Fund was created to support the growth and development of the Catechesis of the Good Shepherd through catechist formation, missionary outreach, and the work of the United States Association of the Catechesis of the Good Shepherd (CGSUSA). The responsibilities of the TLM Fund Committee include:

- compiling requests twice a year, verifying membership and course registration of applicants
- verifying course attendance of scholarship recipients
- discerning and recommending support/award amounts for National Director's final approval
- following up as needed with applicants and recipients.
- collecting testimonials from recipients for impact report

INDEPENDENT AUDITOR'S REPORT

To the Board of Directors United States Association of the Catechesis of the Good Shepherd, Inc. Scottsdale, Arizona

Opinion

We have audited the financial statements of United States Association of the Catechesis of the Good Shepherd, Inc., which comprise the statements of financial position as of June 30, 2023 and 2022, and the related statements of activities, functional expenses, and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of United States Association of the Catechesis of the Good Shepherd, Inc. as of June 30, 2023 and 2022, and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of United States Association of the Catechesis of the Good Shepherd, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Adoption of New Accounting Guidance

As discussed in Note 1 to the financial statements, United States Association of the Catechesis of the Good Shepherd, Inc. adopted the Financial Accounting Standards Board's Accounting Standards Update (ASU) No. 2016-02, *Leases (Topic 842)*, and all subsequently issued clarifying ASUs as of July 1, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about United States Association of the Catechesis of the Good Shepherd, Inc.'s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Activities

The United States Association of the Catechesis of the Good Shepherd, Inc. (the Organization) is a non-profit organization dedicated to supporting catechists, parents, and others in the Church and beyond, as they grow in their understanding of the religious potential of children. The Organization began with the work and observations of Sofia Cavalletti and Gianna Gobbi, and sustains and advances the legacy of the Organization by forming adults in this method and serving as the resource to the Catechesis of the Good Shepherd community so that a prepared environment can be created that nurtures the religious life of the child. The Organization is an association that serves in collaboration with those in the Church and beyond as a respected voice on the child's spiritual development. The Organization is primarily supported by contributions, membership dues, and sales of books and materials.

Accounts Receivable

Accounts receivable primarily represent amounts that are owed for registration fees for National events. Accounts receivable are stated at the amount management expects to be collected from outstanding balances. As of June 30, 2023 and 2022, management has determined, based on historical experience, that all amounts are fully collectible and no allowance for doubtful accounts is necessary.

Beneficial Interest in Assets Held by Oak Park River Forest Community Foundation

The Organization established a fund at Oak Park River Forest Community Foundation (Foundation). The agreement between the Organization and the Foundation states that the transfer of assets is irrevocable and that the transferred assets will not be returned to the Organization. However, the Foundation will make annual distributions of the income earned on the fund subject to the Foundation's spending policy. The agreement also grants variance power to the Foundation, which permits the Foundation to substitute another beneficiary in place of the Organization if the Organization ceases to exist or if the Foundation's board of governors votes that support of the Organization either is no longer necessary or is inconsistent with the needs of the community. The fair value of the fund is based on the fair value of the underlying assets as reported to the Organization by the Foundation. Little information about those assets is released publicly. The estimated fair value does not necessarily represent the amounts that may be ultimately realized due to the occurrence of future circumstances that cannot be reasonably determined.

Inventory

Inventory consists of the Organization's books and materials and is valued at the lower of cost or net realizable value. Cost is determined using the weighted-average cost method.

Investments

Investments at June 30, 2023, consist of certificates of deposit and US government bonds. The Organization reports investments in debt securities at their fair values in the statements of financial position. Unrealized gains and losses are included in the change in net assets in the accompanying statements of activities.

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Equipment

Purchases of equipment in excess of \$2,500 are recorded at cost and depreciated over the estimated useful lives of the assets using the straight-line method.

Contributions

Contributions that are restricted by the donor are reported as increases in net assets without donor restrictions if the restrictions expire (that is, when a stipulated time restriction ends or purpose restriction is accomplished) in the reporting period in which the revenue is recognized. All other donor-restricted contributions are reported as increases in net assets with donor restrictions. When a restriction expires, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statements of activities as net assets released from donor restrictions.

Program Service Revenues

Revenues from sales of books and materials are recognized when the sale takes place. Cost of sales includes costs of goods sold as well as shipping and handling costs to send the merchandise to customers.

Revenues from membership dues is recognized on a straight-line basis over the dues year. Membership is voluntary; therefore, no accounts receivable is recorded and delinquent dues are not recorded as revenue until received. Dues received in the current year for the ensuing year are presented as deferred revenue in the statements of financial position.

Revenues from national events consists of fees for national courses taught by the Organization. Revenue is recognized when courses are held.

Revenues from regional course registration fees are flat fees received per registration for providing recordkeeping and certificates of regional Formation courses. Revenue is recognized when courses are held.

Leases

The Organization does not recognize short-term leases in the statement of financial position. For these leases, the Organization recognizes the lease payments in the change in net assets on a straight-line basis over the lease term and variable lease payments in the period in which the obligation for those payments is incurred. The Organization also does not separate nonlease components from lease components for all classes of underlying assets and instead accounts for each separate lease component. If the rate implicit in the lease in not readily determinable, the Organization uses a risk-free rate as the discount rate for the lease for all classes of underlying assets.

NOTES TO FINANCIAL STATEMENTS June 30, 2023 and 2022

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Expense Allocation

The financial statements report certain categories of expenses that are attributable to more than one program service or supporting activity. Therefore, these expenses require allocation on a reasonable basis that is consistently applied. The expenses that are allocated include personnel, office expenses, and occupancy, which are allocated on the basis of estimates of time and effort. All other expenses are charged to program services or supporting activities based upon the types of services performed and expenses incurred. The following program services and supporting activities are included in the accompanying financial statements:

Program Services – Activities related to supporting catechists, parents, and others in the Church and beyond, as they grow in their understanding of the religious potential of children.

Management and General – Activities necessary to manage the financial reporting and budgetary responsibilities of the organization.

Fundraising – Includes staff time and related expenses to communicate with prospective funding sources.

Adoption of New Accounting Guidance

On February 25, 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update No. 2016-02, *Leases (Topic 842)*. The guidance in this Update and all subsequently issued clarifying Updates supersede the guidance in FASB Accounting Standards Codification (ASC) Topic 840, Leases, and creates FASB ASC Topic 842, Leases. The main difference between previous guidance and Topic 842 is the recognition of assets and liabilities by lessees for those leases classified as operating leases. A lessee should recognize in the statement of financial position a liability to make lease payments (the lease liability) and a right-of-use asset representing its right to use the underlying asset for the lease term. Also, under Topic 842, disclosures are required by lessees and lessors to report useful information to users of financial statements about the amount, timing, and uncertainty of cash flows arising from leases.

The Organization adopted the requirements of Topic 842 as of July 1, 2022, using the optional transition method that allows the Organization to initially apply the new guidance at the adoption date and recognize a cumulative-effect adjustment to the opening balance of net assets in the period of adoption. The Organization's reporting for the year ended June 30, 2022, is in accordance with the previous guidance in Topic 840.

The Organization elected the package of practical expedients permitted under the transition guidance within Topic 842. This package allowed the Organization to account for its leases that commenced before the adoption date without reassessing whether any expired or existing contracts are or contain leases, the lease classification for any expired or existing leases, and initial direct costs for any existing leases.

The adoption of Topic 842 resulted in the recognition of operating lease right-of-use assets of \$37,166 and operating lease liabilities of \$38,775 as of July 1, 2022. The adoption of Topic 842 did not have a material effect on the Organization's change in net assets or cash flows.

NOTE 3 – PAYCHECK PROTECTION PROGRAM

The Organization received two loans totaling \$122,180 under the Paycheck Protection Program (PPP) established by the Coronavirus Aid, Relief, and Economic Security (CARES) Act and administered by the U.S. Small Business Administration (SBA). On March 1, 2021, the SBA preliminarily approved forgiveness of the Organization's first draw loan. On August 17, 2021, the SBA preliminarily approved forgiveness of the Organization's second draw loan. The Organization must retain PPP documentation in its files for six years after the date the loan is forgiven or repaid in full and permit authorized representatives of SBA to access such files upon request. SBA may review any loan at any time at its discretion. Therefore, SBA may review the Organization calculated the loan amount correctly, whether the Organization used loan proceeds for the allowable uses specified in the CARES Act, and whether the Organization is entitled to loan forgiveness in the amount claimed on its application. If SBA determines the Organization was ineligible for the loan or for forgiveness in whole or in part, SBA will seek repayment of the outstanding loan balance.

Certificates of deposit are held at three different national financial institutions. The Federal Deposit Insurance Corporation insures accounts at each institution up to \$250,000. At June 30, 2023, the Organization's certificates of deposit balances were completely insured.

U.S. government bonds are valued using a market approach that uses as inputs observed interest rates and yield curves, prices in active markets for similar assets, and prices for identical assets in inactive markets that have been adjusted by observable indexes, which are Level 2 fair value measurements.

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of financial position.

NOTE 8 - LIQUIDITY AND AVAILABILITY

The following reflects the Organization's financial assets as of the statements of financial position date, reduced by amounts not available for general use within one year of the date of the statements of financial position because of donor-imposed restrictions. General expenditures are defined as all budgeted programmatic and operational expenses.

At June 30, 2022, the Organization's uninsured cash balance was approximately \$52,000. At June 30, 2023, the Organization's cash balances were completely insured.

For the year ended June 30, 2023, approximately 51% of the Organization's revenue was from one foundation.
